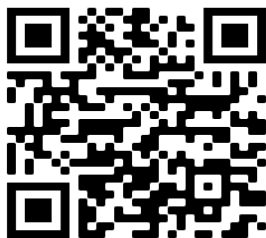

### Program Details WHO IS IT FOR?

The Graduate Diploma merges theory and practice to prepare students for a number of vital roles in the immigration sector, as well as functions that support organizations on immigration and citizenship matters. These include:

- Prospective Regulated Canadian Immigration Consultants (RCICs)
- Paralegals
- Advisors and recruitment specialists at educational institutions
- Human resources professionals
- Leaders in immigrant settlement organizations
- Staff working with members of federal, provincial, and territorial legislatures
- Immigration and border policy analysts and program specialists in government agencies
- Support staff with law firms and immigration consultancy firms

### Program STRUCTURE

The GDipCL program offers two study plans for September and January admission cycles: full-time and part-time. Full-time students will complete 9 courses over 3 consecutive terms in under 12 months, while part-time students will complete 9 courses over 6 consecutive terms in 24 months.

Applicants select their preferred study plan via the application. Study plans are preset for all students and students are enrolled in courses automatically.





# STUDY, interact and collaborate

The Graduate Diploma is designed and delivered entirely online, with live tutorials that feature direct interaction with instructors who are leading experts in the field, as well as digital collaboration platforms to encourage peer-to-peer learning through simulations and discussion forums.

Students must complete all nine courses with a minimum grade of B- to graduate.

## Admission REQUIREMENTS

- Bachelor's degree with a minimum of a B average or equivalent.
- Two references, including one academic reference if you have attended a post-secondary program within two years of applying.
- If English is not a native language, prospective students must meet the English language proficiency requirements in writing, speaking, reading, and listening.
- A personal statement of interest outlining your motivation to apply for the program and how your previous training and/or experience makes you the right candidate for the program. The statement must be written by the applicant, no more than 400 words and completed within the application.

Note: Queen's University is committed to enhancing diversity in graduate education, which includes ensuring mechanisms for applications from prospective students who may not have had opportunity and advantage equal to others to be considered. ## Before you APPLY

1. Take the [GDipICL Self-Assessment](#).
2. Gather all required documents:
  - Transcript(s) for all post-secondary education, whether completed, attempted, or in progress.
  - Valid language scores, if required (see our [admissions page](#) for details).
  - Contact information for two suitable referees (see our [admissions page](#) for details).
  - A personal statement of interest (maximum 400 words) written by the applicant explaining your motivation to apply for the program and how your previous training and/or experiences make you the right candidate for the program.
