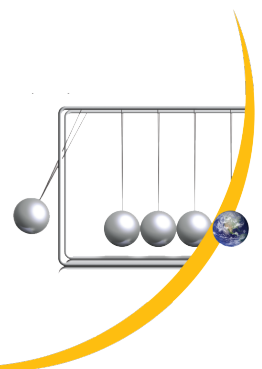

## Program **STRUCTURE**

## WHO IS IT FOR ?

This program merges theory and practice to prepare students for work in any number of areas:

## TIME TO COMPLETE

- Two terms of full-time study (approx.. 45 hours a week)
- Four terms of part-time study if you want to study while fulfilling other commitments
- Students must complete all nine courses with a minimum grade of B- to graduate

## Academic REQUIREMENTS

- A Bachelor's degree from a recognized university.
- Transcripts are required (unofficial transcripts are acceptable).
- Queen's University graduates do not need to submit a transcript.
- A minimum of a B average.
- Language Test Scores: Proficiency in English is a prerequisite for admission. Those applicants whose native languages do not include English will be required to obtain satisfactory standing in an English Language Proficiency Test as part of the application process.

- Transcript from a recognized university
- Language scores, if needed (see website for details)
- Two letters of recommendation
